

# TOWN OF TISDALE

## BYLAW NO. 03/26

### A BYLAW OF THE TOWN OF TISDALE TO ESTABLISH FEES AND CHARGES FOR THE PROVISION OF GOODS AND SERVICES WITHIN THE TOWN OF TISDALE

Subsection 8(1)(i) of *The Municipalities Act*, Council has the power to pass a bylaw for services provided by or on behalf of the municipality, including establishing fees for providing those services;

Therefore, the Council of the Town of Tisdale, in the Province of Saskatchewan, enacts as follows:

1. This bylaw shall be cited as “Fees and Charges Bylaw”.
2. This bylaw establishes fees and charges for certain goods and services provided by or on behalf of the Town of Tisdale.
3. All the fees and charges payable to the Town of Tisdale shall be set out in the following schedules attached hereto:
  - Schedule “A” General Government Services
  - Schedule “B” Protective Services
  - Schedule “C” Planning and Development Services
  - Schedule “D” Environmental Health and Welfare Services
  - Schedule “E” Recreation and Parks Services
  - Schedule “F” Transportation Services
  - Schedule “G” Utilities Services
4. All fees are subject to taxes imposed by applicable law.
5. If a payment (cheque/electronic funds transfer) is returned to the Town of Tisdale due to insufficient funds or closure of the account, the fee is deemed not be received.
6. That unless otherwise stated in the Schedule to this Bylaw, any fees or charges imposed pursuant to this bylaw that are not paid when due are subject to a monthly interest charge of 2% per month, and will be added to the outstanding amount on the first day of each month.
7. This bylaw shall be reviewed annually.
8. This bylaw shall take full force on February 1, 2026 unless otherwise stated in the Schedules.
9. That Bylaw No. 04/14 be hereby repealed.
